

Who are We?

The South African Qualification and Certification Committee for Gas (SAQCC Gas) is body mandated by the Department of Labour to register gas practitioners (installers and mechanics) within South Africa.

SAQCC Gas was formed by the four (4) Member Gas Associations to establish a central database of registered gas practitioners in terms of the relevant legislation, namely, the Pressure Equipment Regulations (PER)



THINK SAFE, BE SAFE. USE A REGISTERED GAS PRACTITIONER!

Why use a registered gas practitioner?

According to the:



NO PERSON SHALL “install or remove a gas appliance, or a gas system or a gas reticulation system, unless such person is an authorised person”

All registered gas practitioners have been trained and proven competent in their specific field, which means they are capable of undertaking gas installations such that they are compliant with the relevant legislation and are therefore deemed to be safe.

It's the only way to make sure that your gas installation is compliant, safe and fit for use.

Therefore it is imperative that only a registered gas practitioner is appointed to work on your gas system.



Certificate of Conformity (CoC)

A CoC must be issued by the gas practitioner on completion of work on the following gas types:

- Liquefied Petroleum Gas
- Natural Gas
- Industrial and Medical Gases
- Air Conditioning and Refrigeration Gases

It is essential that you obtain a CoC from your practitioner

If gas work is not carried out in terms of the Pressure Equipment Regulations and relevant Health and Safety Standards, it will be deemed to be an illegal and unsafe installation. This can lead to a number of potential problems including loss of insurance cover.
