It is pleasing to report that the training manuals for gas installers have been ompleted by a SETA aligned consulting company with a final sign off meeting held on 3rd July. ## **Registrations**

In terms of the Pressure Equipment Regulations (PER), anyone working on a gas system, must be registered with SAQCC Gas as competent within their scope of work. (Regulation1).

If you are aware of any unauthorized person working on a gas system, please report them to SAQCC Gas, who will in turn report them to the Department of Labour.

People working on pressurized systems that fall under the PER, place themselves and the users at risk. This Invalidates insurance and can result in huge losses, should an incident occur. Please report unsafe work!

To date registrations have been flowing well. Each industry sector has seen improved compliance to the (PER). This is because of a number of factors. End users are becoming increasingly aware of their rights and responsibilities, to ensure that the use registered practitioners, and receive a signed Certificate of conformity on completion of the work being done.

To date there has been a total of 2932 practitioners registered with SAQCC Gas. This includes, Compressed Gases, LPGas, Natural Gas, and Refrigeration & Air Conditioning.

## **Regulations & Compliance**

The Department of Labour recently introduced the Pressure equipment Guidelines. The document was published early February this year, and provides notes and explanations for all the sections in the Regulations.

This means less confusion about who can do what. It provides explanations regarding the role of Authorised Inspection Bodies, or AIA's as they are called. It also explains the requirements for issuing of Certificates of conformity, (CoC). Visit the Department of Labour website to get more information: http://wwwlabour.gov.za.

## **Registration Fee**

The fees payable for registration as an Authorised Gas Practitioner have been increased in line with the consumer price index;

New registration applications and renewals from March 2012 to February 2013 will be R1596.00 including VAT.

Replacement of lost cards and for change in details cost R360.00 including VAT.
