

Who is SAQCC Gas?

The South African Qualification and Certifications Committee for Gas (SAQCC Gas) is a body acting on behalf of the Department of Employment and Labour to register Gas Practitioners (Installers) within South Africa.

SAQCC Gas was formed by the four (4) Member Gas Associations to establish a central database of registered Gas Practitioners in terms of the relevant legislation, namely, the Pressure Equipment Regulations (PER).

Are you aware that your insurance company require your gas installation to be compliant?

Certificate of Conformity (CoC)

On completion of the installation, repair, modification and/or maintenance of a gas appliance, system, or airconditioner/refrigeration unit, a Certificate of Conformity (CoC) must be issued by the Gas Practitioner.

If gas work is not carried out in terms of the Pressure Equipment Regulations and relevant Health and Safety Standards, it will be deemed to be an illegal and unsafe installation. This can lead to a number of potential problems including loss of insurance cover.

The CoC is valid for as long as no work has been done on the existing gas system since the original CoC was issued. If any work has been done post the original CoC, a new CoC is issued which supersedes the previous one.

Note: Certificate of Conformity (CoC) is now issued digitally

Gas Practitioners have been trained and proven competent in their specific field, which means they are capable of undertaking gas installations such that they are compliant with the relevant legislation and are therefore deemed to be safe. It's the only way to make sure that your gas installation is compliant, safe, and fit for use. Therefore, it is imperative that only a registered Gas Practitioner is appointed to work on your gas system.

Gas Practitioner licenses will no longer be printed and can now be viewed on the Electronic CoC App as a digital card showing the type of gas work the Practitioner is registered to undertake within the specific field of training.
